IN 2019, THE ORGANIZATION TOOK IN 27,934 ANIMALS. OF THE ANIMALS RECEIVED IN 2019, 61% WERE ADOPTED/RESCUED, 13% WERE EUTHANIZED AND 26% WERE RETURNED TO THEIR OWNERS OR WERE RETURNED TO THE FIELD.
